herein referred to as the Member-Investor, or, Member.

Whereas:

Roteth Investments LLC, herein known as Roteth, Private Club Entity, or Administrator, is in the business of Strategic Administrative Placement of Investment Funds and the Full Servicing of account information for its Members in the Currency Exchange Market.

And whereas both the Administrator and the Member are desirous of entering into a relationship which will be provided on the terms and conditions set forth.

IT IS HEREBY AGREED AND DECLARED AS FOLLOWS:

1) DEFINITIONS AND INTERPRETATION

In this agreement unless the context otherwise requires:

- a. Investor or Member shall mean someone who having been invited or referred by; an existing Member; Director; Company Advertisement; or, a Registered Non-Member so to do and through association thereby with Roteth Investments LLC has expressed a desire to become an investor, and has been approved and accepted by Roteth Investments LLC.
- b. Members Funds or Margin shall mean any investment given to the Administrator at any given time.
- c. Services shall mean any services provided by the Administrator and/or its "Contracted Affiliate Traders" in accordance with best trading practices, including the provision for updating member's accounts, providing account access for members at our web-site using their private identification numbers, e-mail notifications, correspondences and occasional phone calls.
- d. Words expressed in any gender shall include the appropriate gender required by the context used.
- e. In this agreement, words importing natural persons shall include artificial persons being bodies corporate as well as partnerships.
- f. Words expressed in singular shall include the plural.
- g. The headings and clauses in this agreement are inserted only for ease of reference and do not affect the construction of this agreement.

2) TERMS AND CONDITIONS

Membership in ROTETH INVESTMENTS LLC is made by any of the following; an invitation involving a referral from a present or past member; an affiliate; a registered non-member; any management approved literature; web-sites and ads. Any advertised benefits are strictly for members only.

Applicants are required to be of the minimum legal age of eighteen years. An adult or legal entity given the Power of Attorney or Proxy, may act on behalf of a minor or his/her related estate with submission and verification of the legal authorization to do so.

As a Private Club Entity, ROTETH INVESTMENTS LLC reserves the right to refuse, suspend or terminate membership of Members and prospective Members which is a personal contract and cannot be automatically passed on to heirs and successors.

Should an heir or successor apply for membership, ROTETH INVESTMENTS LLC shall give due consideration, and if the circumstances merit, grant membership on such terms and conditions as are applicable to the general membership requirements which may vary from time to time. When membership is refused or discontinued, the

company shall take such steps as are required to settle their outstanding accounts in accordance with established law.

Notwithstanding approval of membership, it is understood, and the investor acknowledges that all funds presented to the company will be subject to affirmative resolution by the appropriate committee of the Affiliate Investment Company or the Administrator before being accepted.

In connection with opening an account the Member acknowledges that he or she has been advised and understand that:

- i. The services provided pursuant to this agreement carry at best a moderate degree of risk, and that the member will be entirely responsible for the risk associated with the provision of services.
- ii. All sums managed pursuant to this agreement will be used as a margin for taking margin-leverage speculative-currency-positions via the Trader. All transactions will be in U.S. dollars only.
- iii. All gains on trades will be added to this margin, and all losses will be subtracted.
- iv. Further losses could arise as a result of fluctuations in the exchange rates, as this will affect currency prices.
- v. The minimum investment amount for membership is \$2000 U.S. dollars. All forms of checks and money orders should be made payable to ROTETH INVESTMENTS LLC. For amounts of (\$10,000.00) or more, the source of funds must be indicated on the application form.
- vi. Margins will not be forwarded for trading activity until they have been initially received and cleared through ROTETH's Administrative Business Account. Payments received in the form of Managers Checks, Money Orders, and Business or Personal Checks will usually take 2 to 4 business days before cleared. Wired funds are considered cleared immediately.
- vii. Cleared funds are held until 12:00 pm Friday each week, at which time the bank wires all funds to the Affiliate Trader(s). The Affiliate Trader(s) will then notify Roteth via e-mail, as to the funds received, and the future start date on which the Funds will begin to trade. (It normally requires 10 business days in order to clear ending cycles and position new funds on the platform to be traded) The start date given by the Trader is the Monthly Anniversary Date. Members are notified immediately by e-mail as to their appointed start date(s).
- viii. Post 9/11 Due Diligence Requirements. All Members are required to provide such information as requested so as to conform to local and international requirements regarding money laundering as well as any other information deemed valid in accordance with these international requirements on demand. Such information will include confirmation of home and work address, and any other due diligence information that may be deemed relevant by the company from time to time and from situation to situation. (see application)
- ix. Because Traders only utilize twenty-five to thirty percent of Margin at any given time, the remaining seventy-five to eighty percent is left uncommitted. Due to this investment approach. Members are thereby guaranteed 75% of their Margin from beginning to end of their contract period.
- x. The anticipated returns on investments to Members is 3.5% & 3.75% monthly. However, the applicable rate from time to time is subject to the amount invested and to any other circumstances that may affect the Trader's ability to trade in any particular month.
- xi. Funds which are placed with ROTETH INVESTMENTS LLC, are accepted for the time period indicated on the application form. Prior to, or at the end of this time period, Members should e-mail their intention to withdraw or reinvest their funds.
- xii. Members may withdraw part or whole of their funds at any given time after giving ten (10) working days notice in writing to ROTETH INVESTMENTS of their intention to do so.
